**Matt Gilligan** is a curator at the Johnson County Museum in Shawnee, Kansas. He holds a Master's degree in History from the University of North Carolina-Charlotte.

**Earl Givens, Jr.** is the Digital Resources Librarian at Emporia State University. Always on the cutting edge of technology, Earl is involved in library projects that push the envelope in academic libraries. Earl is committed to transforming the face of the library by integrating traditional library practices with contemporary technology.

**Ashley Todd-Diaz** is Curator of Special Collections and Archives and Assistant Professor at Emporia State University in Emporia, KS. ## 2012/2013 Minority Internship Report

Karra Whitlock was the 2012/2013 summer KCAA Minority Intern. After the host institution fell through in 2012, Karrah graciously agreed to do her internship this past summer. She is currently enrolled in the Museum Studies Program at the University of Kansas and works as a student assistant for the Conservation Services Department within the University of Kansas Libraries. Karrah is a member of the Cherokee Nation, who received her BA in Anthropology (2004) from Fort Lewis College in Durango, Colorado.<sup>1</sup>

Karra performed the majority of her internship (120 hours) at the National Archives Kansas City Branch, as part of their Graduate Internship Program, under the guidance of archivist Joyce Burner. According to Joyce's review of Karrah's internship, it was characterized by enthusiasm and excellence. It was also obvious that she was very interested in the work assigned to her, and in the end made significant contributions to the work of the National Archives at Kansas City.

While at NARA, Karrah worked on several projects, including the ones listed below:

- Holdings maintenance
- Contributed to an ongoing database transcribing finding aid project
- Wrote descriptions for four record series from the Bureau of Indian Affairs, Rosebud Agency, related to land use and leases, assisted in rehousing a very large series of lease case files, and wrote a "Treasures in the Stacks" article on documents she found in the Rose-

bud Agency records that will be published in the local NARA newsletter

- Prepared a first draft of a preservation information brochure to be distributed to patrons
- Wrote a records-based lesson plan using DocsTeach.org, relating to protests throughout American history.



Overall, Joyce felt that Karrah worked for excellence and accuracy and took feedback and constructive criticism well. She worked well with the staff, volunteers, and patrons.

The remainder of Karrah's internship (80 hours) was conducted at the Kansas Historical Society in the State Archives. While there, she worked with Michael Church, Bob Knecht, and Nancy Sherbert.

To give Karrah the opportunity to work with non-governmental records, Nancy and Bob had her survey, develop an organizational plan, and write a collection level description for a small (3 cft.), recently received manuscript collection from Roger and Hermina Harrison, a farm family from Riley, Kansas. Nancy and Bob were pleasantly surprised by how quickly Karrah picked up on the

different aspects of the project and the short amount of time it took for her to process the collection.

Karra worked with Michael and the digital project staff on several projects for addition to Kansas Memory. She photographed a scrapbook from the Harrison collection mentioned above, created metadata and imaged photographs of Cheyenne Indians, and created metadata for additional photographs that she did not have time to image. Karrah also assisted with imaging oversize maps for preservation purposes.

Overall while at the Kansas Historical Society, Karrah showed an eagerness to learn, picked up on concepts and procedures quickly, and worked easily on her own with minimal supervision.

I am very pleased with this year's Minority Internship and Intern. It was a positive and rewarding experience for all those involved. Having had the opportunity to work with Karrah at KU, I'm not surprised that she was a reliable and efficient intern who quickly picked up on archival principles and theories. I'm positive that in the future, Karrah will continue to make contributions to the archival field through her work in museums.

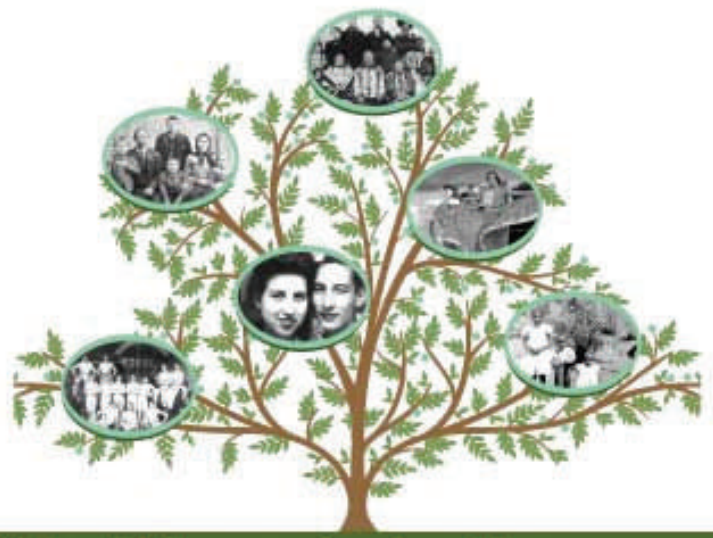

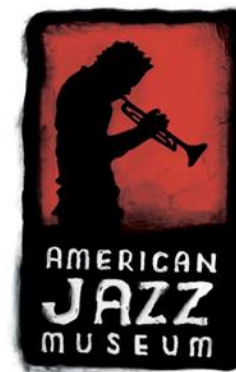

## Dole Archives Awards Research Fellowship

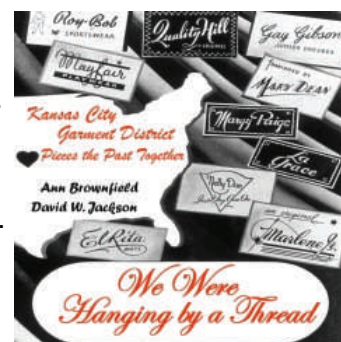
The Dole Archives awarded its 2013-2014 Research Fellowship, a \$2,500 award which supports substantial contributions to the student of Congress, politics, or policy issues on a national or international scale. This year's fellow is Patrick Sandman, a doctoral candidate in United States History at Trinity College, University of Oxford. His dissertation, *Bringing Congress Back In: Watergate and the Politics of Institutional Change*, examines the cultural changes in Congress during the 1960s and its relationship with President Nixon. Sandman conducted research in the Dole Archives the first week of September.

The Dole Archive also hosted Patrick Oluwole Ojo, a travel recipient, for the month of September. Ojo is a doctoral candidate in International Relations at Obafemi Awolowo University in Ile-Ife, Nigeria, working on a dissertation entitled, *Comparative Study of United States' Support for Democracy in Nigeria and South Africa*.

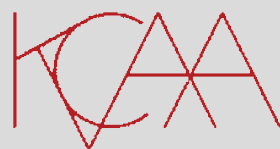
